FRANZ KAFKA – EAT YOUR HEART OUT!

This year marked the 86th anniversary of Kafka's renowned novel 'The Trial' originally called 'Der Process' and recently re-reading it brought a touch of nostalgia in observing your Association's dealings with Woollahra Council. As you may be aware, 'The Trial' recounts the experiences of Josef K who is arraigned before the undefined authorities of a nameless state, without having any idea of the crimes for which he is arrested and then having to deal with an amorphous and largely faceless bureaucracy, in a futile attempt to determine his fate.

Flicking through past minutes of the Association, reading old correspondence and listening to current accounts of conversations with the Council, I was struck by the obvious parallels between these 'works in progress'. In September, I ruefully commented in this journal, on the degraded state of this once-proud precinct. 
Check Out Old Copies of the *Village Voice*

You can now see all the issues of *Village Voice* on the Queen Street and West Woollahra website thanks to Committee member Rosemary McDonald. Rosemary's mother was a stalwart in the early days of the Association and it is great that her daughter is following in her footsteps.

Village Voice started in 1972 under the chairmanship of Leo Schofield and many well known Woollahra identities joined his Committee. Their objective was to save Woollahra from over-development, high-rise and to maintain the unique character of our precinct. This is still our objective.

Over the years Committee members have included Graham Freudenberg, (Gough Whitlams's speech writer), Joy Barraclough, Pat Thompson after whom the park next to the Holdsworth Centre is named and of course Robin Brampton who was the Editor for many years. Other well known members included Neville Gruzeman, June Hazel (first proprietor of the Bay Tree in Holdsworth Street) artist Elwyn Lynn and barrister "Ant" Vincent.

Perusing the newsletters makes interesting reading. Parking and traffic problems have loomed large over the years and the Queen Street Fair really put our precinct on the map. A LABYRINTH FOR CENTENNIAL PARK



On January 26th 1888, Sir Henry Parkes dubbed Sydney's Centennial Park, "The People's Park". More than 124 years later our beloved 'People's Park' is about to receive something new and wonderful in the form of a labyrinth, which is a simple path for walking meditation and contemplation. The Centennial Park Labyrinth is the brainchild of Emily Simpson, a long-time Paddington resident, with a passion for labyrinths. "The design is based on the 800 year old labyrinth in Chartres Cathedral in France. It will be built of sandstone and will be the first major public labyrinth in Sydney. It will be a thing of great beauty - a significant public artwork", she explains. When the original labyrinth was built in the Chartres Cathedral in the early 13th century, it was seen as an alternate form of pilgrimage. During the crusades, the journey to Jerusalem was too dangerous, so people would make their way to one of several Cathedrals across Europe, which at that time all had labyrinths in them.

But the labyrinth doesn't belong to Christianity alone. There are Neolithic petro-glyphs, which show the ancient version of the labyrinth. The Romans had labyrinth mosaic floors. There are coins from the 3rd Century BC in Greece, which have the imprint of the labyrinth on them. Turf labyrinths were created on village greens in the UK and Germany. There are ancient examples in India, China and North and South America. While designs may vary, the use of the labyrinth for meditation and contemplation remains the same across cultures and time. It is a truly universal symbol that is non-denominational and open to people of all faiths. In the last few decades there's been a revival of interest in the labyrinth. In the United States, there have been more than 200 labyrinths built in hospitals alone. Bethesda Naval Hospital near Washington has recently built a labyrinth, which is proving very effective in helping veterans with PTSD.

They are also being built in universities, parks and schools where they are finding that children with ADHD are able to concentrate for longer after walking the labyrinth. "Unlike a maze, which has several different paths and is designed to confuse and frustrate, a labyrinth has a single path, and is designed to soothe and calm. If a maze is an intellectual exercise, a labyrinth is a spiritual one", says Simpson.

John Walker, Chairman of the Board of the Centennial Parklands Trust Says: "When the idea of a labyrinth in the Parklands was first put to the Trust it generated a lot of discussion about whether or not Centennial Park was an appropriate location. It is!! Visitors to the Park come for many purposes - quiet reflection, contemplation and meditation included. A labyrinth will complement the park and provide a wonderful experience. I urge people to get behind this project and make it a reality for current visitors and future generations"

Emily fell in love with the labyrinth several years ago and believes the people who love Centennial Park will too. She is raising the funds to manifest this great public artwork and has created a website for donations. So far the group has raised \$110,000 of the \$500,000 needed to build the sandstone labyrinth. The Poisonous Apple...Organic or non-organic?

As children we all learnt what happened to Snow White when she ate the poisonous apple....however many of us are unaware of the consequences on our own bodies from consuming chemically enhanced foods. While the chemical additives sprayed onto one apple may not harm us, the accumulation of eating hundreds of apples over the years, may be harmful. Chemicals can increase the speed at which cancer develops when mixed with other harmful compounds that may already be stored in your system. They also contribute to the development of various diseases, the disruption of hormone levels, and an increased risk of obesity. Pesticides have been found in the body years after their consumption.

Can I sue the Agent?

I recently bought a terrace-style house in one of Woollahra's leafier avenues, which came with a rare tennis court alongside it. I have since learned that a standard tennis court is supposed to have clearances of at least 3.05 metres along each side-line. On the agent's brochure was a diagram headed "Tennis Court" showing a court with those very clearances. Rightly or wrongly I had instructed my solicitor not to bother getting a fresh survey but to just use the one attached to the contract. That survey contained an identical diagram of the tennis court to the one in the brochure. It now turns out that a newly built wall on next-door's property significantly encroaches onto my tennis court, which is a good metre and a half narrower than it's supposed to be and not one of my friends wants to play on it. To make matters worse, the next door owner has served me with a notice under section 88K of the Conveyancing Act to obtain a formal easement over the land underneath the new wall. The vendor has left the country. Can I sue the agent whose brochure was plainly wrong? I would never have bought the property without a full-size tennis court. The brochure contained the following disclaimer:

"All information contained herein is gathered from sources we believe to be reliable. However we cannot guarantee it's(sic) accuracy and interested persons should rely on their own enquiries". Signed *Misled*

Dear Misled

Relying upon old surveys attached to contracts can be a recipe for disaster, simply because things change - in your case, it was the location of a new wall, in other cases it might be a newly protruding deck, an overhanging gutter or even your own renovations encroaching onto next door's property. And yes, misleading and deceptive conduct by agents and others is actionable under the Competition and Consumer Act 2010 (formerly the Trade Practices Act 1974). Firstly however the agent must be shown to have engaged in misleading and deceptive conduct.

A few years ago the High Court held that where a real estate agent does nothing more than to pass on information which was obviously supplied by others, if it should have been obvious to a prospective purchaser that the agent was not the source of the information, the agent's conduct will not be deceptive or misleading. You would have a tough time proving misleading and deceptive conduct on the part of the agent in your circumstances.

• Chiswick Gardens welcomes a great restaurant again.

We are pleased to welcome Matt Moran and Paul Sullivan to their new **Chiswick Restaurant** located in Chiswick Park, where we hold the community carols each year. Older residents will remember Pruniers Restaurant with affection, a great institution in its heyday. Tony Geminis, the proprietor was a legend. I remember that he even lent money to one of his good customers when he needed to bail out an old friend who had created a scene in another restaurant. It was Saturday night and those were the days before ATMS!

"You will know who you are." I am sure Matt and Paul will have their own tales to tell. Meanwhile we look forward to many superb meals at Chiswick Restaurant starting with the annual QSWWA dinner on May 7.

• Last year the **Woollahra Hotel** tabled a Development Application to Council for footpath use outside the pub and restaurant. The Application was for six tables (24 chairs) to be on the footpath in Queen Street and seven tables (23 chairs) on the footpath in Moncur Street. Hours requested are from 10am to 10 pm. At present the DA is being assessed by Council and details have been sent to the police for comment. A report will be sent to the Development Control Committee in due course. So far 20 submissions have been received from residents; most are overwhelmingly against the proposal. Objections cited are noise, accessibility for pedestrians, and amenity of residents.



It's great to see the new **verandah at Queens Court.** Perfect timing for the wonderful exhibition of Margaret Olley's 27 new works shown at Sotherbys by Brisbane's Philip Bacon Galleries.

- The **Post office closures** have struck again. A letter box drop on March 5 was the only notification Vaucluse residents received before the post office was closed the next day. At least we at Woollahra were not treated with quite such disdain. We had some notice but in spite of petitions and letters to the various ministers our protestations were of no avail. Perhaps the abruptness of the Vaucluse closure was to avoid the expected complaints.
- We still have a post office of sorts. The "Community Post Office" is located in the convenience store Queens Fresh run by James Mo in the main drag. You can buy stamps there and you can leave parcels for collection by Australia Post as long as their weight is not more than 20kg. Australia Post collects letters and parcels between 4 and 5 pm Monday to Friday. You can also direct parcels to be sent to the Community Post Office for your collection.

- At last a **garbage bin has been put in Thompson Park,** adjacent to the Holdsworth Centre. It is a great success and is used by the many picnickers there, so the once rubbish-filled park is now pristine. Nearby residents are delighted.
- Woollahra Council has devised a plan to improve an otherwise mundane structure in our urban environment. Dubbed the signal box art competition local artists have been encouraged to submit designs for the three RTA signal boxes in Rose Bay, Woollahra and Rushcutters Bay. The final selection for the signal box in our area, corner of Jersey Road and Oxford Street, outside the Light Brigade, is illustrated below. An interesting alternative to those boring boxes.



 The popular Wine Library's newest chef, Mitch Orr is a former winner of

the Josephine Pignolet Young Chef of the Year Award and has appeared on *Masterchef*. The Wine Library has seven active beehives on the roof, a welcome contribution to its Oxford Street environment.

- Two "cycle friendly" bumps may be installed in Centennial Park adjacent to the small learn-to-ride track used mainly by children. The plan has angered cyclists, but the Moore Park Trust has claimed that it will enable children and mothers to cross Grand Drive with safety.
- On October 31, 2011Woollahra Council approved the licensed restaurant to be run by tenants, **Small Bar and Kitchens Limited** in the retail and commercial complex at **156 Edgecliff Road.** Residents have been concerned about noise and late trading hours for this new bar type restaurant. Approval was granted subject to the following conditions: Opening hours 7am-10pm (Monday-Thursday, Sunday) 7am-midnight (Friday, Saturday), no amplified music, retractable roof to be closed at 9pm, no alcohol in the courtyard, maximum capacity (including staff).
- Queen Street welcomes yet another fashion label to the strip. **Anna Thomas** has two successful stores in Melbourne and now two in Sydney.
- The old Post Office on the corner of Moncur and Queen Street is being revamped for the famous cosmetic chain **Napoleon Perdis.**

Holdsworth Community Centre to merge with Meals on Wheels and Woollahra Seniors' Community Centre(Gaden Centre)

Sometimes opportunities present themselves which are just irresistible. Holdsworth has been offered the chance to create a new concept for our community which it hopes will form the basis for much improved community interaction and quality of life.

With the support of Woollahra Council, the encouragement of Ageing Disability & Home Care, and at the invitation of Woollahra Voluntary Community Services, Holdsworth is merging the activities of Woollahra Meals on Wheels and the Woollahra Seniors and Community

Centre to create a new community facility. It's 700m around the corner from Holdsworth on the corner of Queen Street and Edgecliff Road at what is known as the Gaden Centre. After renovations at the Centre, which will include improving access and upgrading the kitchen facilities, Holdsworth is set to launch a Community Cafe in early 2013.

Over the rest of 2012 the Holdsworth team will be talking to lots of people to get feedback and support as it brings together three organisations into one. For the next twelve months, there will be few obvious changes other than a single management of the three services by Holdsworth. There is plenty of time to ensure this becomes a really exciting addition to the Woollahra scene. Holdsworth is looking to local businesses and residents



to get behind what they are doing to revitalise the Gaden Centre and to make this a great new community resource. Clearly Meals on Wheels continues as a vital service to house-bound members of our community, but there is nothing to stop the expansion of this model to include Wheels to Meals. Social isolation as an even bigger issue than good nutrition and Holdsworth wants to make sure that every member of the community is supported to connect with other people. To make this happen they will be relying on the fabulous team of people who have been working or volunteering with both Meals on Wheels and the Seniors Centre, many of whom have been doing this unfailingly for up to 30 or 40 years!
